

# CIL - ICPC WORKSHOP ON THE PROTECTION OF SUBMARINE CABLES

## Novotel Hotel, 14<sup>th</sup> (Thursday) and 15<sup>th</sup> (Friday) of April 2011, Singapore

#### **General Information**

The Centre for International Law (CIL) at the National University of Singapore (NUS) and the International Cable Protection Committee (ICPC) are jointly organizing a 1 ½ day *Workshop on the Protection of Submarine Cables* on the 14<sup>th</sup> (Thursday) and 15<sup>th</sup> (Friday) of April 2011, at Novotel Hotel (Clarke Quay), Singapore.

The Workshop will begin on the last day of the 2011 ICPC Annual Plenary held in Singapore from the 12<sup>th</sup> to the 14<sup>th</sup> of April 2011. All ICPC Members attending the 2011 ICPC Plenary are invited to attend the Workshop.

#### **Objective of the Workshop**

The objectives of the Workshop are to, first, educate Governments in the region about the problems in the protection of fibre optic submarine cables (submarine cables), and second, to discuss concrete measures that the cable industry, Governments and international organizations can take to protect submarine cables.

The Workshop hopes to continue the momentum generated by the 2009 CIL *Workshop on Submarine Cables and Law of the Sea*<sup>1</sup> as well as the *General Assembly Annual Omnibus Resolution on oceans and law of the sea* adopted by the UN on 7<sup>th</sup> December 2010.<sup>2</sup> The Resolution, for the first time, called upon States to take measures to protect submarine cables which it described as "**critical communications infrastructure**" and as "**vitally important to the global economy and the national security of all States**."

The Workshop will provide an excellent forum for Government officials, international law experts, relevant international organizations and the cable industry to exchange views on the measures necessary for the protection of such "critical communications infrastructure."

#### **Organization of Workshop**

There will be seven (7) Sessions with two (2) to four (4) presentations in each Session (with the exception of Session 7 which will consist of a panel discussion), covering the various issues.

Panelists will consist of international legal experts, representatives from international organizations, representatives from the cable industry and/or Government officials. Each Panelist will be given 10 to 15 minutes to present.

The topics for discussion will include:

- 1. Causes of submarine cable faults:
- 2. The international legal regime governing submarine cables;
- 3. Best practices for the repair of submarine cables;
- 4. National solutions for the protection of submarine cables including the advantages of adopting cable protection legislation;
- 5. Regional co-operation for the protection of submarine cables including the role of regional bodies such as APEC TEL and Regional Cable Protection Committees;
- 6. The global action needed for the protection of submarine cables including the need for a new instrument to protect submarine cables from acts of terrorism and piracy. The role of intergovernmental organizations such as the International Maritime Organization (IMO) and the International Telecommunications Union (ITU) will also be discussed, along with the possible contribution that the UN Division for Ocean Affairs and Law of the Sea (UNDOALOS) and the ICPC can make in relation to the protection of submarine cables.

After reviewing the Presentations and discussions during the Workshop, CIL and ICPC will prepare a set of draft Recommendations which will be the focus of the discussion in the last Session. Panelists for this Session will include representatives from ICPC, relevant international organizations as well as Government Officials who will give their comments on how best to move forward in the protection of submarine cables.
