

# Student Research Assistants Required



The Centre for International Law (CIL) is seeking 4 NUS students to serve as full-time Student Research Assistants from May-July 2018.

Responsibilities will include one or more of the following projects:

1. **CIL Document Database:** Document analysis and verification of ratification status for ASEAN and Public International Law instruments, and a new collection of Asian Law Materials.
2. **Teaching and Researching in International Law Conference:** Assisting Prof Antony Anghie with the analysis of teaching and researching of international law in the region, and the identification and evaluation of key international law materials that focus on issues, incidents, and disputes in Asia.
3. **Investment Treaties and National Governance Project:** Assisting Dr Dafina Atanasova with identifying relevant Singaporean public law and administrative regulations related to the internalisation of investment treaties and the activity of government officials responsible for dealings with (foreign) investors.
4. **Global Governance Project:** Assisting Dr Ayelet Berman with proof-reading and citation checking of book chapters for an edited book on stakeholder engagement in international governance.
5. **Handbook on Good Treaty Practice** by Prof Robert Beckman and Ms Jill Barret: Editorial assistant responsible for proof-reading, formatting and citation-checking of book chapters.

Applicants are expected to have strong English proficiency, a good command of library and internet research resources, and familiarity with MS Word/MS Excel/Dropbox/Google Drive. Further training will be provided. Student Research Assistants are selected on the basis of their aptitude for research, data analysis, their eye for detail, and their demonstrated interest in programmes and issues served by CIL. Undergraduate and postgraduate students from any school in NUS may apply.

Selected candidates will be invited to attend an interview with a CIL Researcher and an aptitude test.
