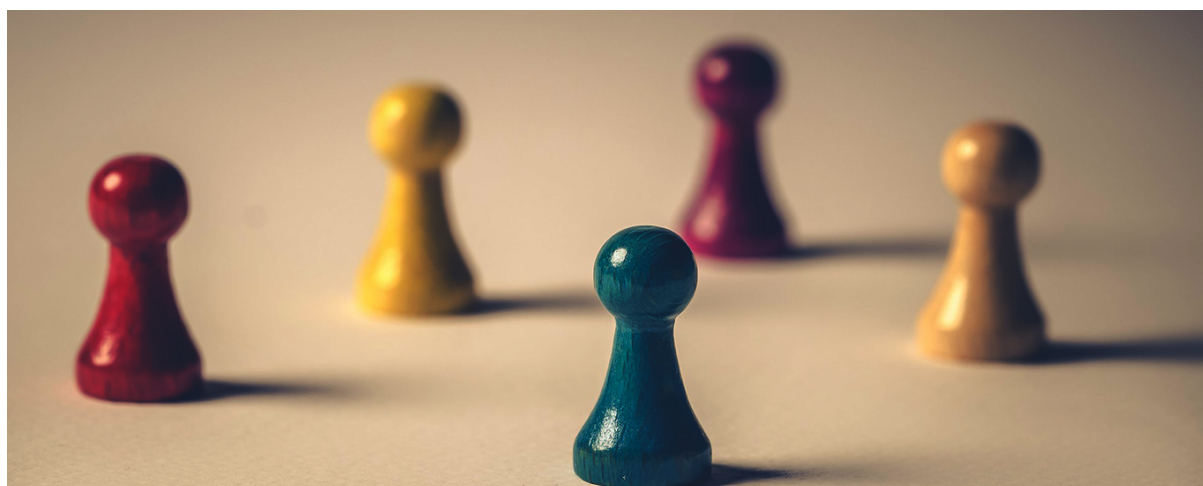


SINGAPORE INTERNATIONAL ARBITRATION ACADEMY 2019
