2 April 2014: Chinese media slams Manila's arbitration attempt as 'against morality'

China on Tuesday accused the Philippines of violating morality and international law by seeking United Nations arbitration in the South China Sea territorial dispute between the two countries.

30 March 2014: Philippines submitted its Memorial to the Arbitral Tribunal

The Memorial presents the Philippines' case on the jurisdiction of the Arbitral Tribunal and the merits of its claims. It consists of ten volumes. Volume I, which is 270 pages in length, contains the Philippines' analysis of the applicable law and the relevant evidence, and demonstrates that the Arbitral Tribunal has jurisdiction over all of the claims made by the Philippines' in its Statement of Claim, and that every claim is meritorious. It sets out the specific relief sought by the Philippines in regard to each of its claims, and shows why it is entitled to such relief. Volumes II through X contain the documentary evidence and maps that support the Philippines' claims, all of which are cited in Volume I.
