## 26 February 2015: PH gives mixed signals on Recto Bank drilling

Two Philippine government agencies gave mixed signals on whether the Philippines will allow oil drilling activities in the Reed Bank. The Philippines' Department of Energy (DOE) said it will suspend the permit of Forum Energy to explore. DFA spokesman Charles Jose, on the other hand, said "Philippine development activity in the West Philippine Sea will take place in accordance with the national interest, following Philippine laws, and in conformity with international law including the United Nations Convention on the Law of the Sea (UNCLOS)."

## 18 February 2015: China Expands Island Construction in Disputed South China Sea

The images provide the first visual evidence that China has built an artificial island covering 75,000 square yards—about 14 football fields—and including two piers, a cement plant and a helipad, at a land formation called Hughes Reef, according to experts who have studied the pictures. ## 17 February 2015: South China Sea Land Reclamation: Satellite Images Show China's Progress on Man-Made Islands

According to images, the land mass is being constructed by China at Hughes Reef in the Spratly Islands. The images show expansion of the land into Johnson South Reef and Gaven Reefs. ## 9 February 2015: Chinese rig finds huge gas reserve in South China Sea

CNOOC 981, China's first deepwater drilling rig, discovered a gas field in the South China Sea with reserves of more than 100Bn m³, announced China National Offshore Oil Corp (CNOOC). China's coast guard sent a dinghy to drive them away according to the law and slightly bumped one of the fishing vessels," Chinese Foreign Ministry spokesman Hong Lei told media. "We ask that the Philippines strengthen education and indoctrination of its fishermen to prevent such incidents from happening again," Hong added.
