#### **Leonardo Bernard**

## Bebeb AKN Djundjunan

Director for Legal Affairs and Territorial Treaties, Ministry of Foreign Affairs, Republic of Indonesia

Mr Bebeb AKN Djundjunan joined the Ministry of Foreign Affairs of the Republic of Indonesia in 1989. Since January 2017, he has been Director for Legal Affairs and Territorial Treaties at the Ministry of Foreign Affairs of Indonesia. His main responsibility is to deal with legal and related issues of land and maritime borders of Indonesia with its ten neighbouring countries.

Mr Djundjunan assumed several positions at the Ministry of Foreign Affairs from 2005 to 2016, among others, as Director for Political-Security and Territorial Treaties, Director for Economic and Social Culture Treaties at the Directorate General for Legal and International Treaties, Deputy Director for Ocean's Treaties at Directorate of Political Security and Territorial Treaties, and Head of Law of the Sea section at the Ministry's Directorate of International Treaties. He was also assigned as Acting Director for International Law at Directorate General of Legal Administration at the Ministry of Law and Human Rights in 2007.

His diplomatic career abroad is as follows. From 2012 to 2016, he was Deputy Chief of Mission at the Embassy of the Republic of Indonesia to the Royal Kingdom of Thailand in Bangkok with diplomatic rank of Minister, and Deputy Permanent Representative of the Republic of Indonesia to the UN-ESCAP in Bangkok. From 2001 to 2005, he was Indonesian Co-managers with Australia at the Regional Support Office of the Bali Process in Bangkok, and Consul for Consular Affairs at the Consulate General of the Republic of Indonesia in Vancouver BC, Canada. From 1994 to 1998, he was Second Secretary for Political Affairs/Legal Officer at the Indonesian Permanent Mission to the United Nations in Geneva.

With special interests on law of the sea, regional maritime security, and intellectual property rights protection, Mr Djundjunan was invited as speaker and resource person to regional and multilateral forums since 1995. He has international law background from the University of Padjadjaran Bandung and the University of Kent, UK. He belongs to the 2002 Cohort on Conflict and Analyze Management at Royal Roads University Victoria BC, Canada. He is currently a doctoral candidate on Legal Studies at Faculty of Law, University of Padjadjaran.

#### **Robert Harris**

Assistant Legal Adviser, East Asia and Pacific Affairs, United States Department of State

Mr Robert Harris is Assistant Legal Adviser for East Asian and Pacific Affairs. In this position he provides legal advice to policy makers on legal issues related to US foreign policy in the Asia and Pacific region. Mr Harris has been a lawyer at the Department of State since 1985 and a member of the Senior Executive Service since 1992. At the State Department he has served as legal adviser and as head of delegation to more than 50 different bilateral and multilateral negotiations on topics such as migration, international aviation and trade in services, counterterrorism, counter-narcotics trafficking, extradition of criminal fugitives, mutual legal assistance in criminal matters, agreements for the protection and management of transboundary watercourses, maritime boundary delimitation, the international law of the sea, marine pollution and dumping at sea, transboundary environmental impact assessment, global environment protection (including persistent organic pollutants and other hazardous chemicals, biological diversity, biosafety, international conservation, and stratospheric ozone protection), sustainable development, international human rights, the protection of refugees, diplomatic privileges and immunities, and nuclear liability.

Mr Harris is an adjunct instructor of international law at the Antonin Scalia School of Law at George Mason University teaching public international law, and a Lecturer in Law teaching the international law of the sea at Columbia Law School. Mr Harris is a graduate of Cornell University (AB History), Princeton University (Masters in Public and International Affairs) and Stanford Law School (Juris Doctor).

## **Professor Tommy Koh**

Chairman, CIL Governing Board, NUS Centre for International Law

Professor Tommy Koh is Ambassador-at-Large at the Singapore Ministry of Foreign Affairs, Chairman of the Centre for International Law, Rector of Tembusu College at the National University of Singapore and Special Adviser of the Institute of Policy Studies. He is the Co-Chairman of the China-Singapore Forum, and the Japan-Singapore Symposium. Professor Koh was the President of the Third United Nations Conference on the Law of the Sea and chaired the Preparatory Committee and the Main Committee at the Earth Summit. He was Singapore's Permanent Representative to the United Nations for 13 years, Ambassador to the United States for 6 years, and the United Nations Secretary General's Special Envoy to Russia, Estonia, Latvia and Lithuania. He was also Singapore's Chief Negotiator for the US-Singapore Free Trade Agreement and has chaired two dispute panels for the WTO. Professor Koh acted as Singapore's Agent in the case concerning Pedra Branca before the ICJ and in the Land Reclamation case before ITLOS. He is a student of international law and, in particular, on law of the sea and environmental law. Professor Koh was named the recipient of the 2014 Great Negotiator Award (an award given out by an inter-university consortium comprising Harvard University, the Massachusetts Institute of Technology, Tufts University and the Future of Diplomacy Project at Harvard Kennedy School).

#### **Lawrence Martin**

Mr Lawrence Martin is a partner in the firm's Washington, DC office and Deputy Chair of its International Litigation and Arbitration Department. Dr Nguyen Dang Thang is currently Director-General (Law & Policy) at the National Boundary Commission of the Vietnamese Ministry of Foreign Affairs. In this capacity, he is responsible for researching and planning policies relating to the settlement and management of territorial and maritime issues, providing advice on questions concerning the international law of territory and the UN Convention on the Law of the Sea, and making recommendations on the interpretation and implementation of boundary treaties concluded by Viet Nam. He is also involved in various bilateral and regional negotiations relating to maritime delimitation, land border demarcation and the management of maritime issues.

Before joining the National Boundary Commission in 2014, Dr Nguyen worked as a legal expert at the International Law and Treaties Department of the Foreign Ministry since 2000, covering wide-ranging international law issues. He maintains an interest in teaching and researching international law, holding a lectureship at the Faculty of International Law, Diplomatic Academy of Viet Nam. He has also been active in the promotion of international law in Asia and Viet Nam, serving as an Executive Member of the Asian Society of International Law since 2013 and being instrumental in the establishment of the Viet Nam Society of International Law in 2016. In 2018, he was appointed by the Government of Viet Nam to be a member of the Permanent Court of Arbitration. Professor Clive Schofield is Head of Research at the Global Oceans Institute, World Maritime University in Malmö, Sweden and is a Visiting Professor at ANCORS. He is a past Australian Research Council (ARC) Future Fellow and QEII Senior Research Fellow. He holds a PhD (geography) from the University of Durham, UK and an LLM from the University of British Columbia, Canada. Professor Schofield's research interests relate to international boundaries and particularly maritime boundary delimitation and marine jurisdictional issues. He has published over 250 scholarly publications, including 22 books and monographs on these issues as well as geotechnical aspects of the law of the sea and maritime security. Professor Schofield serves as an International Hydrographic Office (IHO)-nominated Observer on the Advisory Board on the Law of the Sea (ABLOS) and is a member of the International Law Association's Committee on International Law and Sea Level Rise. He has also been involved in the peaceful settlement of boundary and territory disputes, by providing advice to governments engaged in boundary negotiations and in dispute settlement cases before the International Court of Justice (ICJ). Additionally he served as an independent expert witness in the international arbitration case between the Philippines and China.
