**Alison Duxbury** is a Professor at Melbourne Law School and the Chair of the International Advisory Commission of the Commonwealth Human Rights Initiative.

**Tan Hsien-Li** is an Assistant Professor at the Law Faculty and the Co-Director of the ASEAN Law and Policy Programme at the Centre for International Law, National University of Singapore.

**Yuyun Wahyuningrum** is the Representative of the Republic of Indonesia to the ASEAN Intergovernmental Commission on Human Rights.

#### **Panel Discussion**

The adoption of the ASEAN Charter in 2007 represented a watershed moment in the organisation's history. Since then, developments in the region have included the creation of the ASEAN Intergovernmental Commission on Human Rights in 2009 and the adoption of the ASEAN Human Rights Declaration in 2012.

Despite these advances, many commentators ask whether ASEAN can take human rights seriously. This book explores this question by examining the new ASEAN human rights mechanisms in the context of existing national and international human rights institutions.

At this book launch, the authors—Alison Duxbury and Tan Hsien-Li—will discuss these commitments with HE Yuyun Wahyuningrum, Indonesia's representative to the ASEAN Intergovernmental Commission on Human Rights.
