**Arizona State University**

Daniel Bodansky is a Regents' Professor at the Sandra Day O'Connor College of Law, Arizona State University. He served as Climate Change Coordinator at the U.S. State Department from 1999-2001 and as attorney-adviser from 1985-1989.

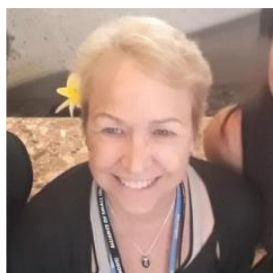
**Nilüfer Oral**
