	<p>Dr Nilüfer Oral</p> <p>Dr Nilüfer Oral is Director of the Centre for International Law. Dr Oral has over 20 years of experience in the study, teaching and practice of international law. She has been a member of the Law Faculty at Istanbul Bilgi University since 1998. In 2016, she was elected by the UN General Assembly to the International Law Commission where she is co-chair of the study group on sea level rise in relation to international law. She has been nominated by Turkey to the International Law Commission (2022– 2027). She has advised the Foreign Ministry of the Republic of Turkey on matters related to the law of the sea and climate change, and served as a climate change negotiator between 2009 and 2016, and attended meetings held by the International Maritime Organization. She has also appeared before the International Tribunal for the Law of the Sea. More...</p>
	<p>Emeritus Professor Robert C Beckman</p> <p>Robert Beckman is the Head of the Ocean Law and Policy programme of the Centre for International Law (CIL) and was the founding Director of CIL. He is also an Emeritus Professor at the NUS Faculty of Law, where he taught Ocean Law & Policy for many years. He currently teaches a course in International Regulation of Shipping at the NUS Faculty of Law. Since 2009 he has lectured in the summer programme at the Rhodes Academy of Oceans Law and Policy in Rhodes, Greece, and he is a member of the Governing Board for the Rhodes Academy. He has published widely on ocean law and policy issues. He is also a Senior Advisor to the Maritime Security Programme of the Institute for Defence & Strategic Studies (IDSS) at the S Rajaratnam School of International Studies (RSIS) at Nanyang Technological University (NTU). He has been nominated by the Ministry of Foreign Affairs of Vietnam as an Arbitrator under Annex VII of the United Nations Convention on the Law of the Sea. More...</p>
	<p>Dr Tara Davenport</p> <p>Dr Tara Davenport is an Assistant Professor at the Faculty of Law, National University of Singapore (NUS) and a Senior Research Fellow at the Centre for International Law (CIL) at NUS. She has an LLB from the London School of Economics, an LLM in Maritime Law from NUS, an LLM and JSD from Yale Law School. She received a Fulbright Scholarship in 2013 and the NUS Overseas Graduate Scholarship in 2014. She is a qualified Advocate and Solicitor in Singapore. Her current research interests are public international law, law of the sea and international dispute settlement. She has written on the South China Sea disputes, submarine cables, deep seabed mining and maritime security issues. She was a member of the Legal Working Group on Liability for Environmental Harm from Activities in the Area convened by the Centre for International Governance Innovation (CIGI), the Commonwealth Secretariat and the Secretariat of the International Seabed Authority.
