ASEAN Law and Policy Academy Flagship Programme 29 July – 5 August 2024



After three years in an online format, the ASEAN Law and Policy Academy returns to an in-person format in its sixth edition, conducted at the National University of Singapore (NUS) Bukit Timah Campus from 29 July – 5 August 2024.

A flagship programme of Centre for International Law (CIL) at NUS, the Academy is a cross-disciplinary master's level intensive programme for policymakers, practitioners, and academics working in the fields of politics and governance, economics, and law. It is founded on twelve years of research at CIL on ASEAN legal integration and institution building, including the [ASEAN Integration Through Law book series](#) published by Cambridge University Press.

Co-directed by Professor Joseph Weiler (New York University (NYU), NUS) and Dr Tan Hsien-Li (NUS), the modules are created and taught by an international faculty of experts from practice and academia and provides participants with a deeper understanding of ASEAN institutions and key developments in ASEAN's economic integration, foreign affairs and legal framework.

The Academy features a revamped syllabus that discusses ASEAN's responses to global issues and contemporary geopolitical shifts. Hence, while the core syllabus of ASEAN's rules-based integration emphasising the importance of legal and institutional frameworks remains, new modules on the ASEAN Economic Community, digital trade, international dispute resolution, law of the sea, climate change, and more are included.

Changemaker Programme (5 days, 29 July – 2 August 2024)

This Programme is designed for policymakers in governments and regional institutions of Southeast Asia and partner countries, as well as practitioners in the private sector and civil society. The Academy enables Changemakers to keep abreast of ASEAN developments, engage in specialised content and practicums on key topics and interact with influential ASEAN researchers and educators. The Changemaker Programme is taught over 5 days between 29 July – 2 August 2024, and is offered in-person only. See the Programme details at page 5.

Educator Programme (6 days, 29 July – 5 August 2024)

This Programme is for tertiary educators and/or researchers teaching and researching issues related to any aspect of ASEAN integration. The Academy's Educator Programme has received acclaim from senior faculty as well as aspiring academics, especially those from the faculties of economics, law, and political science. The Educator Programme comprises the main taught programme from Days 1-5, a half-day workshop on academic publishing and pedagogy, concluding with a full-day academic conference. Presentation at the conference is compulsory for participation in this Programme. Educator Programme participants have the option of in-person or online modalities. (3) *ASEAN Investment Law, Prof Jürgen Kurtz*

- An in-depth module examining regional law and governance in ASEAN through the lens of its unique foreign investment regime. This module includes a hands-on practicum on Investor-State Dispute Settlement in the ASEAN context.

For in-person attendees, spaces in each Specialisation are limited. The organisers will endeavor to allocate to applicants their first choice Specialisation.

Programme

The main lecture series for the Changemaker and Full Educator Programmes runs from 29 July – 2 August 2024. Lectures and seminars will be conducted primarily at NUS Bukit Timah Campus. Educator Programme participants have the option to attend the taught classes from 29 July – 2 August 2024 in person, or online. Application

Only selected applicants will attend the Academy. Applicants should be fluent in English, and should fulfil at least one of the following requirements:

- Familiarity with at least one aspect of ASEAN cooperation in either a practitioner or academic setting, OR
- Comparative expertise in law, public policy, political science or economics in one or more Southeast Asian countries, OR
- Has completed the [ASEAN Law Academy Foundation Programme](#), OR
- Has attended previous iterations of the Academy.

Programme Directors and Trainers

Professor Joseph Weiler

Professor Joseph Weiler is University Professor at NYU, as well as holder of the European Union Jean Monnet Chair at NYU School of Law. He was President of the European University Institute (EUI) in Florence, Italy from 2013–2016. He serves as Co-Editor in Chief of the European Journal of International Law (EJIL) and the International Journal of Constitutional Law. He is also Professor at NUS; Honorary Professor at University College, London; Honorary Professor at the Department of Political Science, University of Copenhagen; and Co-Director of the Academy of International Trade Law in Macao, China. Professor Weiler served for many years as a member of the Committee of Jurists of the Institutional Affairs Committee of the European Parliament, inter alia co-drafting the European Parliament's Declaration of Human Rights and Freedoms. He is a WTO and NAFTA Panelist. Professor Weiler is author of articles and books in the fields of international, comparative, and European law. His publications include: *The Constitution of Europe – do the New Clothes have an Emperor?* (Cambridge University Press 1998); *The EU, the WTO, and the NAFTA: Towards a Common Law of International Trade?* (Academy of European Law, EUI, Florence/Oxford University Press, 2000); *Un'Europa Cristiana* (Rizzoli, 2003), *The Worlds of European Constitutionalism* (with Gráinne De Búrca) (Cambridge University Press, 2012), and a novella, *Der Fall Steinmann* (Piper, 2000).

Dr Tan Hsien-Li

Dr Tan Hsien-Li is the Co-Director of the ASEAN Law and Policy Programme at CIL and Associate Professor at the Faculty of Law, NUS. In 2023, Dr Tan received the Pingat Kepujian (The Commendation Medal) for her contributions to Singapore and the region on ASEAN integration. Dr Tan researches on ASEAN integration and public international law, particularly on institution building and norm creation; and human rights and peace and security. She has published in EJIL, Human Rights Law Review, and Michigan Journal of International Law. She is also the author/co-author of three books on ASEAN human rights institutionalisation and rules-based compliance in ASEAN (Cambridge University Press 2011, 2016, 2019). She is a Co-Editor of the Asian Journal of International Law and the general Co-Editor (together with Professor Joseph Weiler) of the ASEAN Integration Through Law Book Series (Cambridge University Press). She has held fellowships at EUI, Florence, and the Jean Monnet Center for International and Regional Economic Law and Justice, NYU School of Law. She was also the AsianSIL Research Fellow at NUS and the Ushiba Memorial ASEAN Fellow in Tokyo.
