



SIAC and the Centre for International Law, NUS, are pleased to present the SIAC-CIL Academic-Practitioner Colloquium.

The seminar provides academics and arbitration practitioners with a platform to showcase their current research work, and to test their ideas on a panel of fellow arbitration practitioners and academics. Together, we aim to raise the level of discourse in the field of international arbitration.

Counsel, Valuation, and Experts in Investment Treaty Arbitration

The discussion will draw on Dr Tobias Traxler's paper, "Counsel, Valuation, and Experts in Investment Treaty Arbitration". The valuation of damages in investment treaty arbitrations raises significant practical problems. Based on original interview data, Dr Traxler's work shows that arbitrators frequently struggle to understand valuation analyses, especially complex, speculative, and intransparent discounted cash flow analyses. Building on this insight, the paper advances its central thesis: because arbitrators struggle to understand valuation analyses, valuation experts and, in turn, counsel influence outcomes on the valuation of damages in investment treaty arbitrations. Valuation experts tend to be influential if their analysis seems credible, they are well-reputed, and they effectively relay their expert knowledge to arbitrators. In turn, counsel shape valuation outcomes by selecting and instructing valuation experts, through their advocacy, and during cross-examinations. Experts' and counsels' influence may advantage players who spend more on their legal case. Dr Traxler proposes two policy interventions to eradicate resulting inequities: ensuring financial literacy among adjudicators and regulating valuation.


