**Dr Jon Truby** 

Visiting Research Associate Professor, Centre for International Law, National University of Singapore

Dr Jon Truby is a Visiting Research Associate Professor in AI & Technology Law at the Centre for International Law, National University of Singapore, where he leads research on the intersection between AI law and international law, with a focus on sustainability and the application of AI governance to the SDGs. He chairs the International Law Association Committee on AI & Technology Law and serves as a participating expert to the OECD.AI Expert Group on AI Compute and Climate. Previously Director of the Centre for Law and Development at Qatar University, he has been an Academic Visitor at Oxford's Institute for Ethics in AI and a Visiting Fellow at Newcastle University Law School. He holds a PhD from Newcastle Law School and practiced in a top global law firm in London before academia.

**Director of the Centre for International Law (NUS)** 

Nilufer Oral is Director of the Centre of International Law at the National University of Singapore. She is a member of the UN International Law Commission (ILC) and served as Co-chairperson of the 74th session w. She is also a Co-chair of the ILC Study Group on sea-level rise in relation to international law. In addition, she is a member The Hague Academy of International Law Curatorium and an associate member of the Institut de Droit International. She was a legal advisor and climate change negotiator for Turkish MFA (2009-2016). She is currently a Member of the Committee of Legal Experts of the Commission of Small Island States on Climate Change and International Law (COSIS). She is a Distinguished Fellow of the Law of the Sea Institute at Berkeley Law and a Senior Fellow of the National University of Singapore Law School.

Ms.Lucia Velasco

### Head of AI Policy, United Nations Office for Digital & Emerging Technologies (UN ODET)

Lucia Velasco is a Spanish-Argentinian economist and researcher who serves as the Head of Al Policy at the United Nations Office for Digital and Emerging Technologies. She advises the UN Under-Secretary-General and Special Envoy on Technology and guides the Organisation's work on Al governance. Her career began in the Spanish Parliament, followed by senior government roles and later the World Economic Forum in Geneva, where she led work on Al governance. She is affiliated with the Oxford Martin School and the Maastricht School of Economics, serves as an independent expert to the European Commission and the OECD, is the author of a book, and chairs the Future of Work stream within the Global Partnership on Al (GPAI).



Mr.S. Krishnan

#### Secretary of the Ministry of Electronics and Information Technology (MeitY), Government of India

S. Krishnan is the Secretary in India's Ministry of Electronics and Information Technology and leads the country's national AI strategy. He steers India's AI policy priorities and the vision behind the upcoming AI Impact Summit while overseeing Meity's central role in supporting the growth of India's AI ecosystem. A member of the Indian Administrative Service since 1989, he has over 35 years of public service, including roles as Additional Chief Secretary for Industries, Investment Promotion and Commerce in the Government of Tamil Nadu and Senior Advisor in the Office of the Executive Director for India, Sri Lanka, Bangladesh, and Bhutan at the International Monetary Fund. He has also represented India in the G20 Expert Groups on International Financial Architecture and Global Financial Safety Nets.



Ambassador Indra Mani Pandey

### Secretary General, BIMSTEC

His Excellency Ambassador Indra Mani Pandey is the Secretary General of BIMSTEC, having assumed office in January 2024. A distinguished career diplomat of the 1990 batch of the Indian Foreign Service, he has served as India's Permanent Representative to the United Nations and other International Organisations in Geneva, as well as Ambassador of India to the Sultanate of Oman. He has also held senior postings, including Deputy Chief of Mission in France and Consul General in Guangzhou. In his current role, His Excellency provides leadership to BIMSTEC's efforts to deepen regional cooperation among the Member States of the Bay of Bengal region.

Research Fellow, Centre for International Law, NUS.

Sze Hong Lam ('Ocean') is a researcher at the Centre for International Law, National University of Singapore. He holds an Advanced LLM from Leiden University, as well as a PCLL and LLB from the University of Hong Kong. He has previously worked at the Legal Office of the OPCW and the Office of the Prosecutor of the IRMCT and has been an elected member of the Steering Committee of the ESIL Interest Group on the History of International Law since 2023. His postdoctoral research at CIL focuses on how Artificial Intelligence challenges existing doctrines of international law, including sovereignty and individual criminal responsibility, with a particular interest in the position of small states in great power competition.



Mr. Looi Teck Kheong

### Global AI Ambassador, Global Council for Responsible AI (GCRAI)

Mr Looi Teck Kheong is the Global AI Ambassador at the Global Council for Responsible AI and Principal Consultant specialising in digital economy regulation and governance. Previously, he served as Assistant Director for Market Integration of the ASEAN Economic Community, a role he held concurrently with the position of Head of ASEAN's Competition, Consumer Protection, and Intellectual Property Division, where he directed the development of the region's core digital market policies. He is also the author of the internationally acclaimed book Cybersecurity – Guardians of the Digital Frontier (Amazon 2024), which explores cybersecurity laws, governance, and policies in Singapore and the region. With over 35 years of experience, Mr Looi has played a leading role in shaping digital and technological policy frameworks that balance innovation, competition, and ethics at a regional level, including developing the ASEAN Consolidated Strategy for the Fourth Industrial Revolution. Mr Looi is also an advocate and solicitor admitted to the Supreme Court of Singapore in 1990, with extensive private practice experience before transitioning into public policy, regulatory, and strategic legal advisory.



**Professor Stephen Minas**

Dr Stephen Minas is a professor of law at the Peking University School of Transnational Law (STL) and director of its Sustainability Innovation and Law Circle (SILC). Stephen is the chair of the UN Climate Technology Centre & Network Advisory Board, a member and former chair of the UNFCCC Technology Executive Committee, and has participated as both a negotiator and co-facilitator in UN climate negotiations. As a Grade One Officer of the Sri Lanka Foreign Service, he brings over two decades of experience in diplomacy, economic affairs, and development administration, with diplomatic assignments in Sri Lanka Missions in Amman, Canberra, London and Beijing. He most recently served as Director General of the Middle East Division at the Ministry of Foreign Affairs, Foreign Employment and Tourism. Recent speaking engagements include the UN Headquarters in Geneva (May 2025) on Building Legal Capacity in Arab States, the WTO Public Forum (Sept 2024) on Sustainable Trade and Entrepreneurship, Waseda University's IPIRA Conference (April 2025) on ADR in IP Disputes and SDG 16, and Harvard University's Gulf Creatives Conference (May 2024) on IP as a Catalyst for Development. Dr Samuel White is Senior Research Fellow in Peace and Security at the Centre for International Law, National University of Singapore. He serves as Editor-in-Chief of the Journal of the Royal Australian Historical Society, as well as an editor of the United States Military Academy's Articles of War and the Adelaide Law Review. He holds visiting and adjunct positions with the Australian Defence Force Academy, the Australian War Memorial, the University of New England and the University of Adelaide, and has been recognised as an Associate Fellow of the Royal Historical Society and a Fellow of the National Library of Australia. Alongside his academic work, Dr White has served as an officer in both the Royal Australian Infantry Corps and the Australian Army Legal Corps in tactical, operational and strategic roles. He is editor of the multi-volume series The Laws of Yesterday's Wars and has worked as a Senior Legal Officer in the Office of International Law, Commonwealth Attorney-General's Department. He is admitted to practise in Australia and New Zealand. At CIL, he is contributing to the West Point Manual on International Law Applicable to Artificial Intelligence in Warfare, a project co-led by the Lieber Institute for Law and Land Warfare at the United States Military Academy at West Point, with the support of an international consortium of experts and institutions, including the Centre for International Law, NUS.
