#### **Dr. Elena Pribytkova**

*Senior Research Fellow, Centre for International Law, National University of Singapore*

Dr. Elena Pribytkova received a Doctor of the Science of Law (J.S.D.) degree from Columbia Law School and is a Habilitation candidate at the Faculty of Law of the University of Basel. Her main research areas are Human Rights Law, Public International Law, Digital Technologies, Environmental Law, Sustainable Development, Comparative Law, and Legal and Political Philosophy. In particular, she focuses on the role of international law and human rights in reducing poverty and inequality as well as in promoting social, global, digital, and environmental (including climate) justice and sustainable development. Elena has held various research and teaching appointments at leading universities and research institutes all over the world, including Columbia Law School, New York University School of Law, University of Oxford, European University Institute, Max Planck Institute for Comparative Public Law and International Law, Heidelberg University, Swiss Institute of Comparative Law, University of Basel, University of Michigan Law School, and National University of Singapore.

## PANEL 1: HOW INTERNATIONAL LAW SHOULD REGULATE DIGITAL TECHNOLOGIES?



### **Mr. Benjamin Ang (Moderator)**

*Head of the Centre of Excellence for National Security and Head of Digital Impact Research at the S. Rajaratnam School of International Studies*

Mr. Benjamin Ang is a Senior Fellow at RSIS, where he heads the Centre of Excellence for National Security (CENS), Future Issues in Technology (FIT), and Digital Impact Research (DIR). He leads work on cyber and national security, hybrid threats, social resilience, and the policy implications of AI, space, quantum, smart cities, and biotechnology. He has testified at the UN Open-Ended Working Group on cyber issues and before Singapore's Select Committee on Deliberate Online Falsehoods, and lectures at the UN–Singapore Cyber Fellowship. A former litigator, technology lawyer, IT director, and lecturer, he holds an LL.B. (NUS) and MBA/MS-MIS (Boston University). He is Co-Chief Data Officer at AI Singapore and serves on the Internet Society Singapore Chapter's Executive Committee.



### **Mr. Tony Oweke**

*Multilateral negotiator on AI at the United Nations and Advisor, Permanent Mission of the Republic of Kenya to the United Nations*

Mr. Tony Oweke is a diplomat at the Permanent Mission of the Republic of Kenya to the United Nations, where he serves as a negotiator for the Group of 77 and China (134 countries) on artificial intelligence. In the Global Digital Compact process, he championed the International Independent Scientific Panel on AI and the AI Governance Dialogue, and is currently negotiating G77 positions on their structure, mandate, and functions through the modalities resolution. Beyond digital policy, Mr. Oweke has chaired negotiations on UN macroeconomic resolutions and Executive Board decisions, represents Kenya in the Second Committee, and advances governance reforms across multiple UN agencies' boards. Strengthening institutional accountability, strategic oversight, and cross-regional collaboration for sustainable development.



**H.E. Anita Ashvini Wahid**

*Indonesian Representative to the ASEAN Intergovernmental Commission on Human Rights*

H.E. Anita Ashvini Wahid is Indonesia's Representative to the ASEAN Intergovernmental Commission on Human Rights (AICHR) for 2025–2027. A human rights and digital-democracy advocate, she focuses on countering disinformation, strengthening civic resilience, and advancing inclusive governance. Within AICHR, she contributes to regional dialogues on conflict prevention, the right to peace, and victim protection in trafficking. She is also an Australia Awards scholar pursuing a PhD at the Australian National University. She has served as Chair of the Democracy & Human Rights Desk at Jaringan GusDurian and as a member of TikTok Asia Pacific's Safety Advisory Council.



**Mr. Dimitri Gugunava**

*Head of Digital Governance and Cyber Security Strategic Planning and Analytical Unit LEPL Digital Governance Agency Ministry of Justice of Georgia; Head of the Georgian Delegation in the Committee on Artificial Intelligence of the Council of Europe*

Mr. Dimitri Gugunava is Head of the Digital Governance and Cybersecurity Strategic Planning and Analytical Unit at Georgia's LEPL Digital Governance Agency with more than fifteen years of public service experience in digital governance cybersecurity and personal data protection. Internationally he leads the Georgian delegation to the Council of Europe Committee on Artificial Intelligence since March 2022 and has served as a member of the Committee Bureau since September 2024 and he was elected co-chair of the Georgian Cybersecurity Public-Private Partnership in 2023 and again in 2024. He is also active in international work on artificial intelligence and cybersecurity governance advancing collaborative rights respecting and ethics informed digital policy. Beyond government service he teaches personal data protection law as a visiting lecturer at several universities in Tbilisi and has published several papers on digital governance, cybersecurity and privacy. He holds an LLB and an LLM from Ivane Javakhishvili Tbilisi State University Faculty of Law and is currently pursuing a PhD.



**Prof. Başak Çalı**

*Head of Research, Bonavero Institute of Human Rights, University of Oxford*

Professor Başak Çalı is Head of Research and Professor of International Law at the Bonavero Institute of Human Rights, University of Oxford, and is affiliated with Mansfield College and the Law Faculty. Previously a professor of international law and founding director of the Centre for Fundamental Rights at the Hertie School in Berlin, she also holds a permanent visiting professorship at the University of Copenhagen's I-Courts and is a fellow of the University of Essex Human Rights Centre. Her work spans the authority of international law, standards of review, and European, UN and comparative human rights law; she co-founded the European Implementation Network and has served as an expert and practitioner on the European Convention on Human Rights.

As Executive Director, she advances research, education, and strategic advocacy to embed Indigenous rights in global climate finance and policy processes. She is an expert on the UN treaty body to the Convention on the Elimination of Discrimination against Women (CEDAW) and Co- Chair of the WPS Agenda where she drafted the new international framework on Women Peace and Security and is the Chair of the Individual Complaints. She is also the Gender Adviser to the President of the UN General Assembly and Vice Chair of the International Bar Association's Human Rights Institute. She has been a Visiting Fellow at Oxford and Leader in Practice at Harvard Kennedy School of Government's Women in Public Policy Program. Dr. Otani is currently President of Child Rights Connect, a Geneva-based global network of child rights civil society organizations. She is also a Commissioner and a member of the Executive Committee of the International Commission of Jurists, a member of the Executive Committee of the Asian Society of International Law. She holds a Bachelor of Law in international legal studies from Sophia University in Tokyo, a Master of International and Public Affairs in human rights and humanitarian affairs from Columbia University, School of International and Public Affairs in New York, a Master of Law in public international law from University of Tokyo, Graduate School of Law and Politics in Tokyo, and Doctor of Law in public international law from Aoyama Gakuin University, Graduate School of Law in Tokyo. For the academic year 2023-2024, Ms. Otani was a visiting professor at Leiden University Law School, as the Chair in Enforcement of Children's Rights.

Professor Sun Sun Lim is Vice President (Partnerships & Engagement) and Lee Kong Chian Professor of Communication and Technology at Singapore Management University's College of Integrative Studies. Her research examines the social impact of technology, spanning technology domestication in families, the future of work, and AI ethics and data governance and she has authored over 100 publications, including *Digital Parenting Burdens* (2024) and *Transcendent Parenting* (2020). A Fellow of the International Communication Association and the Singapore Computer Society, she serves on Singapore's Media Literacy Council, the Skills Future Research Advisory Panel, and the Singapore Environment Council, and previously served as a Nominated Member of Parliament (2018–2020). Recognised among the 2024 Top 50 Asia Women Tech Leaders and the 2020 Singapore 100 Women in Tech, she is also a regular commentator in international media and writes a monthly technology column in *The Straits Times*.

*U.N. Special Rapporteur on the Right to Development; Professor at Macquarie Law School, Australia*

Professor Surya Deva is Professor at the Macquarie Law School and Director of Macquarie University's Environmental Law Research Centre. He is also the UN Special Rapporteur on the Right to Development. He is an internationally recognised scholar in the field of business and human rights and he is a former member of the UN Working Group on Business and Human Rights (2016-22). Deva researches in the areas of business and human rights, comparative constitutional law, international human rights law, sustainable development, climate change, and gender equality. He is one of the founding Editors-in-Chief of the *Business and Human Rights Law Journal* and is an elected Vice President of the International Association of Constitutional Law (2022-26).



**Dr. Jon Truby**

Professor Jon Truby is Visiting Research Associate Professor in AI & Technology Law at the Centre for International Law, National University of Singapore, where he leads research on AI law, sustainability, and the application of AI governance to the SDGs; he chairs the International Law Association's Committee on AI & Technology Law and serves as a participating expert to the OECD.AI Expert Group on AI Compute and Climate. Previously Director of the Centre for Law and Development at Qatar University, he has been an Academic Visitor at Oxford's Institute for Ethics in AI and a Visiting Fellow at Newcastle University Law School. **Dr. Samuel White (Moderator)**

*Senior Research Fellow, National University of Singapore*

Dr. Samuel White is Senior Research Fellow in Peace and Security at the Centre for International Law, National University of Singapore. A scholar-practitioner of military and public law, he is Editor-in-Chief of the Journal of the Royal Australian Historical Society, an Editor of West Point's Articles of War and the Adelaide Law Review, and a Visiting Fellow at the Australian Defence Force Academy (2023–2025) and the Australian War Memorial (2024–2027). His military service spans the Royal Australian Infantry Corps and the Australian Army Legal Corps, with postings from platoon command to strategic legal roles. His doctorate examined constitutional limits on military responses to foreign interference. He authored *Keeping the Peace of the Realm* (LexisNexis, 2021), edits *The Laws of Yesterday's Wars* (Brill Nijhoff), and is admitted in Australia and New Zealand.

Gyan's work focuses on the geopolitics of AI, platform and data governance, and the institutional design of democratic oversight over digital infrastructures. He has contributed to several high-impact policy reports and is a co-author of a new book, "Information Ecosystems and Troubled Democracy" published by Nordicom at the University of Gothenburg. Active in global Internet governance spaces, he serves as an Internet Society Youth Ambassador 2025 and frequently engages in multistakeholder forums on encryption, media freedom, and the governance of large platforms. Across these roles, he works to embed rights-centric, Global South perspectives into evolving AI and platform governance regimes.



**Dr. Eric J.W. Orlowski**

Dr. Eric J. W. Orlowski is an anthropologist and technologist serving as a policy-focused Research Fellow in AI Governance at AI Singapore, where he leads research on AI ethics and governance. His work examines the societal and cultural impacts of emerging technologies through a human-centric lens, with current projects on cultural alignment in AI models, mapping Singapore's AI ecosystem, and reframing governance beyond risk management. He holds a PhD in sociocultural anthropology from University College London; his thesis – on techno-optimism and techno-utopianism in Sweden – was defended in September 2024 after 18 months of fieldwork. He is affiliated with NUS's Centre for Computational Social Science and Humanities, is a vetted consultant to UNDP, an affiliated researcher at Uppsala University, and has collaborated with AI Sweden and Malaysia's National AI Office through expert working groups on AI governance.

His AIES 2024 paper, “Measuring Human-AI Value Alignment in Large Language Models”, introduces a novel metric for assessing how well models align with human values, taking into account the inherent non-determinism of LLMs.
