Professor JHH Weiler is University Professor at New York University School of Law and Senior Fellow at the Center for European Studies, Harvard. He served as President of the European University Institute in Florence, Italy from 2013–2016. He was co-founder and an Editor-in-Chief of the *European Journal of International Law* and is currently Co-Editor-in-Chief of the *International Journal of Constitutional Law*. He has a regular teaching appointment at the National University of Singapore.

In 2025, Professor Weiler was received the Barry Prize for lifetime intellectual achievement by the American Academy of Sciences and Letters and the Manley Hudson Medal, the highest honor awarded by the American Society of International law. In 2022 he was awarded the Ratzinger Prize by Pope Francis.

In the world of practice, Professor Weiler served, inter alia, as a member of the Committee of Jurists of the Institutional Affairs Committee of the European Parliament, co-drafting the European Parliament's Declaration of Human Rights and Freedoms. He is an experienced arbitrator in the framework of the WTO and USMCA.

Professor Weiler is author of numerous articles and books in the fields of international, comparative, and European law. His book *The Constitution of Europe – Do the New Clothes have an Emperor?* (CUP) has been translated into 8 languages. His novella *Der Fall Steinmann* (Piper) was a best seller in Germany. He has five children and four grandchildren and is a passionate gardener and beekeeper.

Sze-Wei manages the ASEAN Law and Policy programme at CIL together with Programme Head Professor Joseph Weiler. They oversee CIL's annual flagship programmes of the ASEAN Law and Policy Academy and Global Trade Law Academy, as well as the CIL Document Database and its collection of ASEAN and International Law instruments.

Sze-Wei's research focuses on the development of ASEAN institutions and legal frameworks, and is a continuation of their work on the ASEAN Charter process from 2006-2007 where they assisted Singapore's representatives to the Eminent Persons' Group on the ASEAN Charter, then-Deputy Prime Minister S Jayakumar and chairman of the High Level Task Force on the ASEAN Charter Ambassador-at-Large Tommy Koh. They were also an editorial assistant for the book *The Making of the ASEAN Charter* (eds Koh, Rosario and Woon, World Scientific 2009) and *The ASEAN Charter: A Commentary* (Walter Woon, 2015). They left the Singapore Foreign Service in 2008 and joined CIL in 2009.

Ambassador Rena Lee is a dedicated and seasoned practitioner of international law, at the international and national level, serving as a government legal advisor, diplomat and international negotiator. She was appointed Ambassador for International Law in 2023, and prior to that, served as Ambassador for Oceans and Law of the Sea Issues and Special Envoy of the Minister for Foreign Affairs. In the latter role, she was elected as President of the United Nations Intergovernmental Conference on the Conservation and Sustainable Use of Marine Biological Diversity of Areas Beyond National Jurisdiction (BBNJ), where she presided over complex negotiations over five years which successfully culminated in the adoption, by consensus, of a landmark international agreement under the United Nations Convention on the Law of the Sea. She was also elected and served as a member of the Legal and Technical Commission of the International Seabed Authority from 2017 to 2022.

Ambassador Lee's public international law practice includes advising the Singapore Government for more than three decades, both with the International Affairs Division of the Attorney-General's Chambers and the Ministry of Defence. She has broad expertise over a wide range of international law matters, including law of the sea, climate change and environmental law, international humanitarian law, and human rights law.

Ambassador Lee is a Member of the Permanent Court of Arbitration.

PANGESTU	 Professor Mari Elka PANGESTU Presidential Special Envoy for International Trade and Multilateral Cooperation Mari Pangestu is the Special Envoy of the President of the Republic of Indonesia for International Trade and Multilateral Cooperation, and Vice Chair of the National Economic Council. She previously served as the President's Special Envoy for Climate Finance and advised the Coordinating Ministry for Maritime and Investment Affairs on sustainability, energy transition, and blended finance (2023–2024). From 2020 to 2023, she was Managing Director of Development Policy and Partnerships at the World Bank. Earlier, she was Indonesia's Minister of Trade (2004–2011) and Minister of Tourism and Creative Economy (2011–2014). She has over 30 years of experience across academia, diplomacy, international organisations and government. She is currently Professor of International Economics at the University of Indonesia and a Board Member of the Centre for Strategic and International Studies (CSIS) in Jakarta. She is also a Distinguished Visiting Fellow at the Peterson Institute for International Economics and at the Center for Global Energy Policy at Columbia University, as well as an Honorary Professor at the Crawford School of Public Policy, Australian National University. She earned her bachelor's and master's degrees in economics from the Australian National University, and her PhD in economics from the University of California, Davis.
TAY	 Associate Professor Simon SC Tay Chairman, Singapore Institute of International Affairs Professor Simon SC Tay is a public intellectual as well as an advisor to major corporations and policymakers. He is currently (1) Chairman of the Singapore Institute of International Affairs, a globally ranked think tank; (2) Associate Professor at the National University of Singapore Faculty of Law; (3) Senior Consultant with WongPartnership, a leading regional law firm; (4) Ambassador for Singapore; and (5) Board Member to Maritime and Port Authority of Singapore, a statutory board under the Ministry of Transport. (6) Non-Executive Independent Director with the board of Certis Cisco. Previously, Professor Tay has taught at Harvard Law School and Yale University, served on boards for leading global companies including MUFG Bank of Japan, Toyota Japan, and Deutsche Boerse (Asia), and been Corporate Advisor to Temasek Holdings. He has also served Singapore as Chairman of the National Environment Agency and Nominated Member of Parliament.

Simon Chesterman is David Marshall Professor of Law and Vice Provost (Educational Innovation) at the National University of Singapore, where he is also the founding Dean of NUS College. He serves as AI Governance and Policy Lead at the NUS AI Institute and Editor of the *Asian Journal of International Law*. Previously, he was Dean of NUS Law from 2012 to 2022 and Co-President of the Law Schools Global League from 2021 to 2023.

Educated in Melbourne, Beijing, Amsterdam, and Oxford, Professor Chesterman's teaching experience includes periods at the Universities of Melbourne, Oxford, Southampton, Columbia, and Sciences Po. From 2006-2011, he was Global Professor and Director of the New York University School of Law Singapore Programme. Prior to joining NYU, he was a Senior Associate at the International Peace Academy and Director of UN Relations at the International Crisis Group in New York.

Professor Chesterman is the author or editor of more than twenty books, including *We, the Robots? Regulating Artificial Intelligence and the Limits of the Law* (CUP, 2021) and *One Nation Under Surveillance* (OUP, 2011). He also writes on legal education and higher education more generally and is the author of five novels including the *Raising Arcadia* trilogy and *Artifice*.

Dr Hew is a Senior Research Fellow at the Centre on Asia and Globalisation, at the NUS Lee Kuan Yew School of Public Policy. His research focuses on regional economic integration, international trade, economic security and geoeconomics.

From 2011 to 2022, Dr Hew served as Director of the APEC Policy Support Unit, the research and analytical arm of the Asia-Pacific Economic Cooperation. Dr Hew was previously with the Asian Development Bank, where he worked in the Southeast Asia Department managing technical assistance programs on regional cooperation and integration.

An economist by training, Dr Hew holds a B.A. (Hons) in Economics from the University of Warwick and both an M.Sc. and Ph.D. in Finance from the University of Manchester, United Kingdom. He has published widely on ASEAN economic integration, trade policy, and regional cooperation in the Asia-Pacific. Joel co-pioneered the teaching of Negotiation and Mediation in the Singapore Universities and has played a significant role in furthering the development of mediation in Singapore, not just in education but in practice. A graduate of Victoria University of Wellington and Harvard Law Schools, Joel is a principal mediator with the Singapore Mediation Centre and a Master Trainer with Peacemakers. Joel was a member of the International Mediation Institute's Independent Standards Commission and Intercultural Taskforce and was also a key member of the Ministry of Law's Working Group on International Commercial Mediation. Joel is the founding and immediate past Chair of the Board of the Singapore International Mediation Institute. He is also a Certified Trainer of Neuro-Linguistic Programming (NLP). Joel has taught overseas at the University of Copenhagen (Denmark), University of Law, Economics and Science of Aix-Marseille (Aix-en-Provence France) and Anglia Law School (UK) and is the co-editor and co-author of the book "An Asian Perspective on Mediation" and the "Singapore Mediation Handbook", and the General Editor for the Asian Journal on Mediation. In 2011, Joel was awarded the Outstanding Educator Award which is the National University of Singapore's highest teaching award. Joel was also awarded the Singapore's Public Service Medal in 2023 for his work in promoting mediation.

He negotiated Singapore's free trade agreements with the European Union, China, ASEAN, the Eurasian Economic Union, the Comprehensive & Progressive Trans-Pacific Partnership (CPTPP), as well as investment treaties with various countries. Professor Tan researches on ASEAN integration and public international law, regional integration and resilience, and political economy. She has published in the <i>European Journal of International Law</i>, <i>Human Rights Law Review</i>, and <i>Michigan Journal of International Law</i>. She is also the author/co-author of three books on ASEAN human rights institutionalization and rules-based compliance in ASEAN (Cambridge University Press 2011, 2016, 2019). She is a co-editor of the <i>Asian Journal of International Law</i> and the general co-editor (together with Joseph Weiler) of the <i>ASEAN Integration Through Law Book Series</i> (Cambridge University Press).

TAN	 Mr Jason TAN Senior Director / Senior State Counsel Attorney General's Chambers, Singapore Jason Tan advises the Singapore Government on international law. He is Senior Director and Senior State Counsel at the International Affairs Division, and helms the practice on security, proliferation, and international crime engagement. Jason was the lead legal advisor for the negotiations of the Indo-Pacific Economic Framework for Prosperity and was the lead counsel for the Regional Comprehensive Economic Partnership, the world's largest free trade agreement. He served as Counsellor (Legal) at the Permanent Mission of Singapore in Geneva, Switzerland, and specialized in WTO dispute settlement. Jason also worked on the Association of Southeast Asian Nations (ASEAN)-China free trade agreement, the Comprehensive Economic Cooperation Agreement between Singapore and India, the ASEAN Trade in Goods Agreement, the Railway Land Arbitration (Malaysia/Singapore) at the Permanent Court of Arbitration, and the Case concerning Land Reclamation by Singapore in and around the Straits of Johor (Malaysia v. In 2015, Mr Wong was an Associate (International Arbitration and Public International Law) at Freshfields Bruckhaus Deringer before returning to AGC in 2017. In AGC, Mr Wong advises and represents the Singapore Government on a broad range of public international law issues, such as the law of the sea and environmental law, and international economic law.
